

CRIMINAL JUSTICE (CJ)

CJ G046 4 Units (80 lecture hours)

Civilian Supervisory, Law Enforcement

Grading Mode: Pass/No Pass
Not Transferable.

P.O.S.T. certified course providing newly appointed or experienced civilian supervisors with formal training in the concepts, techniques and practical application of basic supervisory skills as they pertain to police operations. An eighty hour, two week course. Pass/No Pass.

CJ G054 2 Units (30 lecture hours; 10 lab hours)

Police Academy, Regular Basic Course, Orientation

Grading Mode: Pass/No Pass
Not Transferable.

This course is designed to familiarize the student with the police academy training program and provide a better understanding of the requirements and commitments that must be considered. This comprehensive program will assess the suitability and employability of potential academy recruits. Students will be required to complete job-related tests in preparation for the police academy and a career as a police officer. A four-week course. Pass/No Pass.

CJ G061 1 Unit (24 lecture hours)

Training Manager

Grading Mode: Pass/No Pass
Not Transferable.

This course is designed for those entering employment as a Training Manager at a California Law Enforcement Agency. The course will cover topics such as legal mandates and regulation, developing training manuals, updating training and compliance issues. This course is required by the California Commission on Peace Officers Standards and Training (POST). Pass/No Pass.

CJ G064 33 Units (399 lecture hours; 611 lab hours)

Police Academy - Regular Basic Course

Prerequisite(s): CJ G054.

Grading Mode: Standard Letter
Not Transferable.

This course provides Basic Police Academy training in compliance with the minimum standards established by the California Commission on Peace Officer Standards and Training (POST). POST certified training includes: criminal law, search and seizure, laws of evidence, traffic laws and procedures, investigative techniques, patrol procedures, firearms, vehicle operations, defensive tactics, physical fitness, report writing, and first aid / cardio pulmonary resuscitation. Students must pass a criminal history check pursuant to California Penal Code section 13511.5, and possess a valid driver's license. Graded.

CJ G070 4 Units (80 lecture hours)

Sergeant Supervisory, Law Enforcement

Grading Mode: Pass/No Pass
Not Transferable.

This course is required for California peace officers who have been promoted, appointed, or transferred to a first-level supervisory position. The California Commission on Peace Officers Standards and Training requires a peace officer who will be appointed within 12 months to a first-level supervisory position or an officer assigned to a quasi-supervisory position to attend the course if authorized by their respective department. This course aims to prepare the first-level supervisor to lead within their respective law enforcement agency. The topics discussed in this course include: Accountability; Communications in a Diverse Workforce; Conflict Management; Counseling; Critical Incident Management; Employee Relationships; Ethical Decision-Making; Evaluating Employees; Internal Affairs Investigations; Leadership Styles and Behaviors; Power and Authority; Recognizing and Documenting Employee Performance; Role Identification and Transition; Stress Management; Team Building; Training Employees; Values. Pass/No Pass.

CJ G078 6.5 Units (120 lecture hours)

Public Safety Dispatcher Basic (Intensive Format)

Advisory: The student must be currently employed as a dispatcher for a public safety agency.

Grading Mode: Standard Letter
Not Transferable.

This course aims for the student to understand the basic roles, responsibilities, and duties of a dispatcher within a public safety agency. Graded.

CJ G079 6.5 Units (120 lecture hours; 0 lab hours)

Public Safety Dispatcher Basic (Extended Format)

Grading Mode: Standard Letter
Not Transferable.

This course aims to provide the student with an understanding of the basic roles, responsibilities, and duties of a dispatcher within a public safety agency. This course provides standardized dispatcher training and introduces students to the skills and knowledge necessary to work in a communications center in a productive and professional manner. This extended format course is approved by the California Commission on Peace Officer Standards and Training (P.O.S.T.) and is designed for the entry-level student who is not currently employed as a dispatcher with a public safety agency. Graded.

CJ G080**2 Units (40 lecture hours)****Communications Training Officer****Prerequisite(s):** CJ G078 or CJ G079.

Advisory: Recommended for students with a minimum of one year experience as a public safety dispatcher.

Grading Mode: Pass/No Pass
Not Transferable.

The course will provide the student with a fundamental understanding of the role and duties of the Communications Training Officer (CTO). The student will apply effective instructional strategies and understand methods for evaluating novice public safety dispatchers. The student will demonstrate coaching and mentoring skills through interactive experiences, such as role-playing, simulations, and written exercises. Concepts to be covered will include instructional techniques, student assessment and evaluation. Pass/No Pass.

CJ G090**24.5 Units (327.5 lecture hours; 355 lab hours)****Specialized Investigator's Basic Course (SIBC)**

Prerequisite(s): Current employment as a Specialized Investigator or Specialized Investigator Trainee in a California law enforcement agency.

Grading Mode: Standard Letter
Not Transferable.

This course teaches the basic knowledge, skills and ethical standards to satisfy the minimum required qualifications established by the California Commission of Peace Officers Standards and Training (POST) for employees serving as Specialized Investigators in the State of California. The course includes academic, physical, psychomotor and affective (ethical behavior) student learning objectives. Letter grade does not guarantee receiving a POST certificate. Students must achieve success in all domains established by POST standards to be awarded a POST certificate of completion. Graded.

CJ G092**4 Units (80 lecture hours)****SWAT, Special Weapons And Tactics, Basic****Prerequisite(s):** CJ G064.

Grading Mode: Pass/No Pass
Not Transferable.

Concepts, planning, tactical operations, approach/entry/search techniques; use of chemical agents, weapons, rappelling and task-related physical activities. A two-week course. Pass/No Pass.

CJ G095**3 Units (40 lecture hours; 40 lab hours)****Leadership Development Program For Law Enforcement****Prerequisite(s):** CJ G064 and CJ G070.

Grading Mode: Pass/No Pass
Not Transferable.

This course is designed to teach the necessary components for examining and learning the essentials of leadership and to recognize and distinguish issues which influence police integrity, public trust, and loyalty. It analyzes the evaluation policy of the law enforcement agency. It appraises the current system, and examines how assertive leadership influences the behavior and performance of subordinates. It also teaches preparation and formulation of employee performance appraisals. It compares and assesses the supervisor's role in the disciplinary process. In addition, it examines connection between leadership and effective communication. The difference between civil and criminal accountability will be explored and debated along with the concept and application of Community Oriented Policing and Problem Solving. Pass/No Pass.

CJ G099**2 Units (24 lecture hours; 16 lab hours)****P.O.S.T. Instructor Certification****Prerequisite(s):** CJ G064.

Grading Mode: Pass/No Pass
Not Transferable.

This course specifically addresses delivery of the POST (California Commission on Peace Officer Standards and Training) Basic Course curriculum and is designed to expand and enhance the competency and effectiveness of the criminal justice instructor. Course components are structured to deal with the subject matter expertise, various instructional techniques, adult learning concepts, student driven learning and validation exercises. Pass/No Pass.

CJ G110**3 Units (54 lecture hours)****Criminal Investigation****Grading Mode:** Standard Letter**Transfer Credit:** CSU.

This course addresses the fundamentals of criminal investigation including searches, interview and interrogation techniques, crime scene investigation, sources of information, and case preparation and management. Graded. **C-ID:** AJ 140.

CJ G123**3 Units (54 lecture hours)****Juvenile Law****Grading Mode:** Standard Letter

Transfer Credit: CSU; UC: Credit Limitation: CJ G123 and CJ G141 combined: maximum credit, 1 course.

This course provides a study of the American juvenile justice system including the roles of the three components of the criminal justice system: law enforcement, courts, and corrections. It examines patterns of criminal delinquent behavior and the historical and modern theories that aim to explain delinquent behavior and strategies to mitigate it. This course also examines dependent children as a result of abuse and neglect. Graded.

CJ G128 Criminal Procedure & Evidence Grading Mode: Standard Letter Transfer Credit: CSU.	3 Units (54 lecture hours)	CJ G146 Police Report Writing Grading Mode: Standard Letter, Pass/No Pass Transfer Credit: CSU.	3 Units (54 lecture hours)
This course provides an overview of procedural criminal and evidentiary law. This course examines state and federal constitutional, statutory, and case law governing criminal prosecutions and post-conviction proceedings. Graded.		Techniques communicating facts, information and ideas in an effective, simple, clear and logical manner, as they are applied to various types of reports and memoranda used in the criminal justice system. Emphasis is on criminal justice technology, interviewing techniques, the proper use of English, organization of information, and practical application of these areas in note taking, proper completion of felony and misdemeanor crime reports, memos and routine forms, and the presentation of testimony in court. Graded or Pass/No Pass option.	
CJ G137 Community Relations And Special Issues In Criminal Justice Grading Mode: Standard Letter Transfer Credit: CSU; UC.	3 Units (54 lecture hours)	CJ G150 Introduction To Corrections Grading Mode: Standard Letter Transfer Credit: CSU; UC.	3 Units (54 lecture hours)
This course addresses multiple social issues challenging law enforcement today. It explores the vital aspects of Community Oriented Policing (COP) and Problem-Solving, Proactive/Reactive Policing (ROP/POP), cultural diversity, prejudice/discrimination/hate/stereo-typing/victim selection/victimization, and other social forces that shape human values and attitudes. The course examines current demographic trends, dynamics, and interactions of California's minority groups and multi-faceted sub-cultures as they relate to the criminal justice system in a free society. Graded. C-ID: AJ 160.		This course will examine the history, theories, and practices concerning the institutionalization of criminal offenders in America. Students will study probation and parole systems, as well as jail and prison programs currently in use in the United States. Incarceration trends will be analyzed along with the political environment's effect on the prosecution and sentencing process. Students will explore different crime causation theories and how they relate to historical and modern effectiveness in community-based corrections programs. Students will gain a historical and theoretical understanding of the issues related to managing inmates in institutions, and the constitutional issues that surround the corrections system. Graded.	
CJ G140 Introduction to Criminal Justice Advisory: ENGL G100.	3 Units (54 lecture hours)	CJ G151 Practical Aspects Of Corrections Advisory: CJ G150. Grading Mode: Standard Letter Transfer Credit: CSU.	3 Units (54 lecture hours)
This course analyzes the characteristics of the criminal justice system. The course introduces students to the history of criminal law, the legal process, and theories of punishment. The course focuses on the interrelationship of the criminal justice system components in a multicultural context, crime reporting methodology, theories of crime causation, and current challenges to the system. Graded. C-ID: AJ 110.		This course is a follow-up course to CJ G150 (Introduction to Corrections) and explores practical aspects of the modern correctional environment. It includes concepts of correctional ideology including professionalism, victimology, restorative justice, sentencing, diversion, juveniles in the adult system, and issues related to inmates with special needs. This course also studies the characteristics and needs of male, female, and juvenile inmates, and explores constitutional issues related to these inmate classifications. Graded.	
CJ G141 Concepts of Criminal Law Advisory: ENGL G100. Grading Mode: Standard Letter Transfer Credit: CSU; UC: Credit Limitation: CJ G123 and CJ G141 combined: maximum credit, 1 course.	3 Units (54 lecture hours)	CJ G172 P.C. 832 - Laws of Arrest Grading Mode: Pass/No Pass Transfer Credit: CSU.	2 Units (32 lecture hours; 12 lab hours)
Formerly: Criminal Law I. This course offers an analysis of the doctrines of criminal liability in the United States and the classification of crimes against persons, property, morals, and public welfare. Special emphasis is placed on the classification of crime, the general elements of crime, the definitions of common and statutory law, and the nature of acceptable evidence. This course utilizes case law and case studies to introduce students to criminal law. The completion of this course offers a foundation upon which upper-division criminal justice course will build. The course will also include some limited discussion of prosecution and defense decision making, criminal culpability, and defenses to crimes. Graded. C-ID: AJ 120.		This course is designed to satisfy the curriculum standards of the California Commission on Peace Officer Standards and Training (POST) as required by California Penal Code section 832 for Laws of Arrest. Course topics include professional orientation, criminal justice system, community relations, introduction to criminal law, laws of arrest, search and seizure, presentation of evidence, investigative report writing, use of force/baton, preliminary criminal investigation, arrest and control procedures (which will require a physical skills demonstration), crimes against the justice system, and cultural diversity. Pass/No Pass.	

CJ G220

3 Units (54 lecture hours)

Forensic Accounting, Introduction

Grading Mode: Standard Letter, Pass/No Pass

Transfer Credit: CSU.

This course is identical to ACCT G220. This course provides an introduction to forensic accounting. The course examines the application of investigative accounting skills to collect, analyze, and evaluate evidential matter, as well as the interpretation and communication of such evidentiary findings in the a court of law or other business or administrative venue. Topics include fraud detection, fraud investigation techniques, the legal environment surrounding forensic accounting, business valuation, and professional ethics and responsibilities. Graded or Pass/No Pass option.
